Section 8 – End of Grant Transition

SECTION 8 - End of Grant Transition

The Grantee must cooperate with TWC to assist with the orderly transfer of the services, functions, and operations provided by the Grantee to another service provider if the Grantee is not awarded funding under a subsequent RFA. Grantee shall develop and implement a reasonable transition plan ("Transition Plan") designed to achieve an efficient transfer of customers and programs, if applicable, prior to the end of the grant. The Transition Plan will specify tasks to be performed, the task schedule, and the respective responsible parties. The Transition Plan will be completed within 30 days of notification from TWC of non-award status.

Reminders for CDER

- Effective **July 1**, there are two more cost categories in CDER:
 - **Career Services:** required cost category per OCTAE Memo 17-2 and is a requirement for Federal Reporting.
 - **IET Training services:** required cost category for Federal Reporting; budget due in CDER by **August 15**
 - IELCE
 - Reminder: We cannot add or move money within Year 6 (ALAF) until <u>August 1</u> when the Expenditure Reports for July become available in CDER.

Adverse Action Process

Technical Assistance Plans & Corrective Action Plans *Process and Tracking*

What's the Difference: TAP

TAP: Technical Assistance Plan:

- Non-Punitive
- As described in §802.104, is a performance improvement action, which can be developed jointly between TWC and an AEL grant recipient in order to improve a grant recipient's performance or compliance
- do not exclude a grant recipient from receiving an annual workforce award

What's the Difference: CAP

CAP: Corrective Action Plan:

- Can be Punitive
- To assist in correcting any deficiencies, a Board, AEL grant recipient, or Agency grantee upon whom an intent to sanction or a sanction is imposed must enter into a corrective action plan. A corrective action plan is developed by the Agency and may include the elements of a technical assistance plan, as outlined in §802.104(b) of this chapter
- Does exclude a grant recipient from receiving an annual workforce award
- Cannot qualify for statewide leadership grants
- Must be mentioned when applying for Core Grant RFA

Qualifying for a TAP

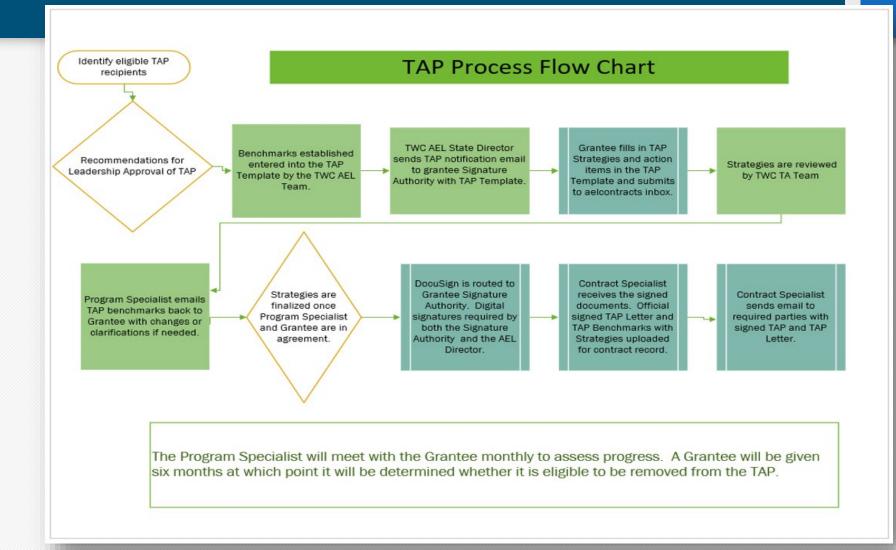
- NLF: AEL grant recipients must be aware that TWC will place a grant recipient on a TAP for failure to meet any five of the seven contracted measures for four consecutive months, which may cross program years, as indicated on the grant recipient's MPR.
 *PY 22-23 looked at not meeting 3 out of 4 measures (total enrollment, IET enrollment, Intensive enrollment, and MSGs).
- NLF: AEL grant recipients must be aware that TWC may also place a grant recipient on a TAP for programmatic or fiscal compliance issues as a result of a regular performance review, monitoring review, site visit, or ongoing data management concerns. This policy is further explained in the Texas AEL Guide.
