Civics Content Area Overview

Texas Adult Education and Literacy Content Standards v. 3 are organized around five broad Content Areas. The Citizen/Community Member Content Standards are Content Area V. Within each Content Area, there are Subareas that delineate the different topics within the Content Area. Subareas typically consist of several Content Standards and Benchmarks. This structure assists in breaking a broad Content Area into manageable groupings of information.
