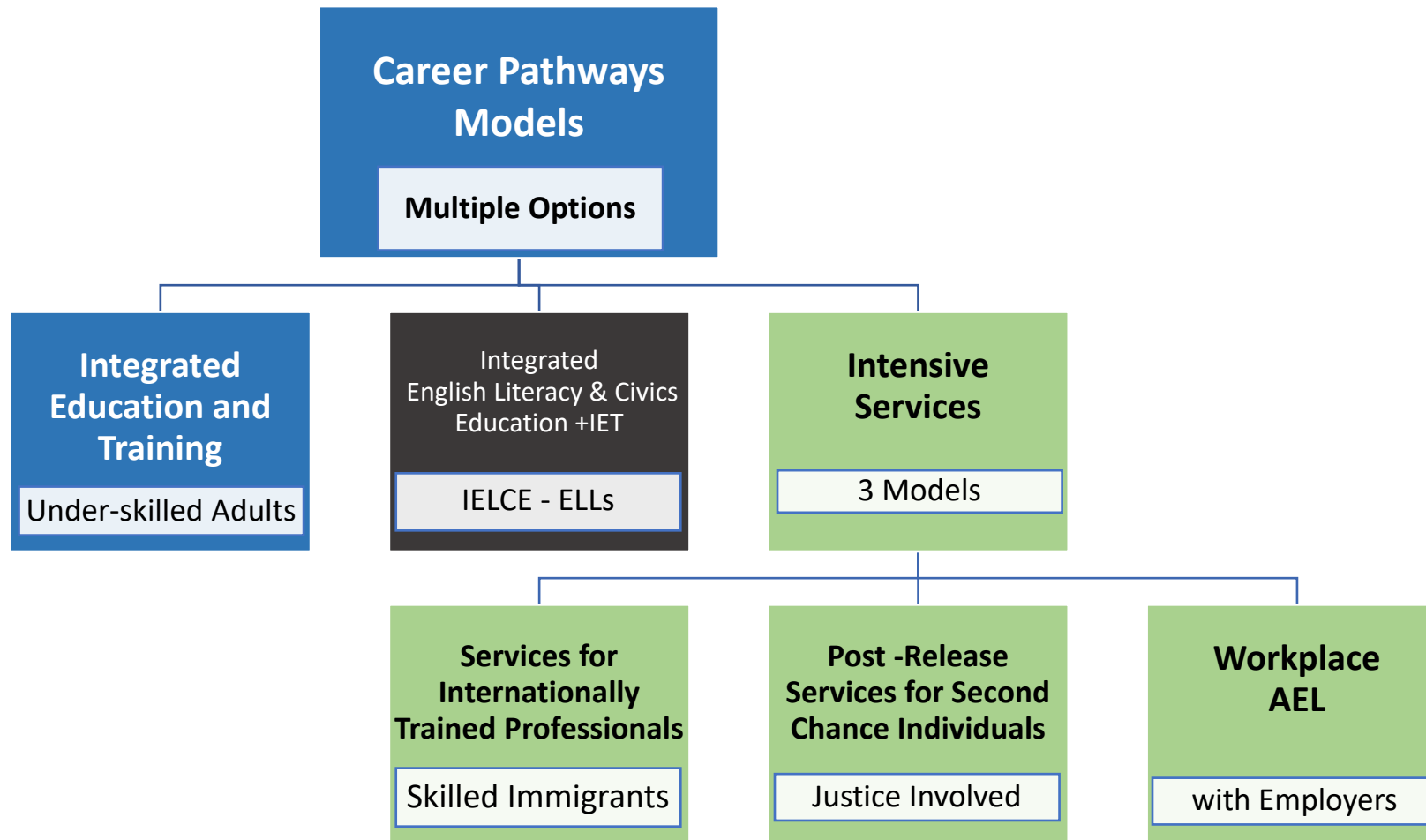

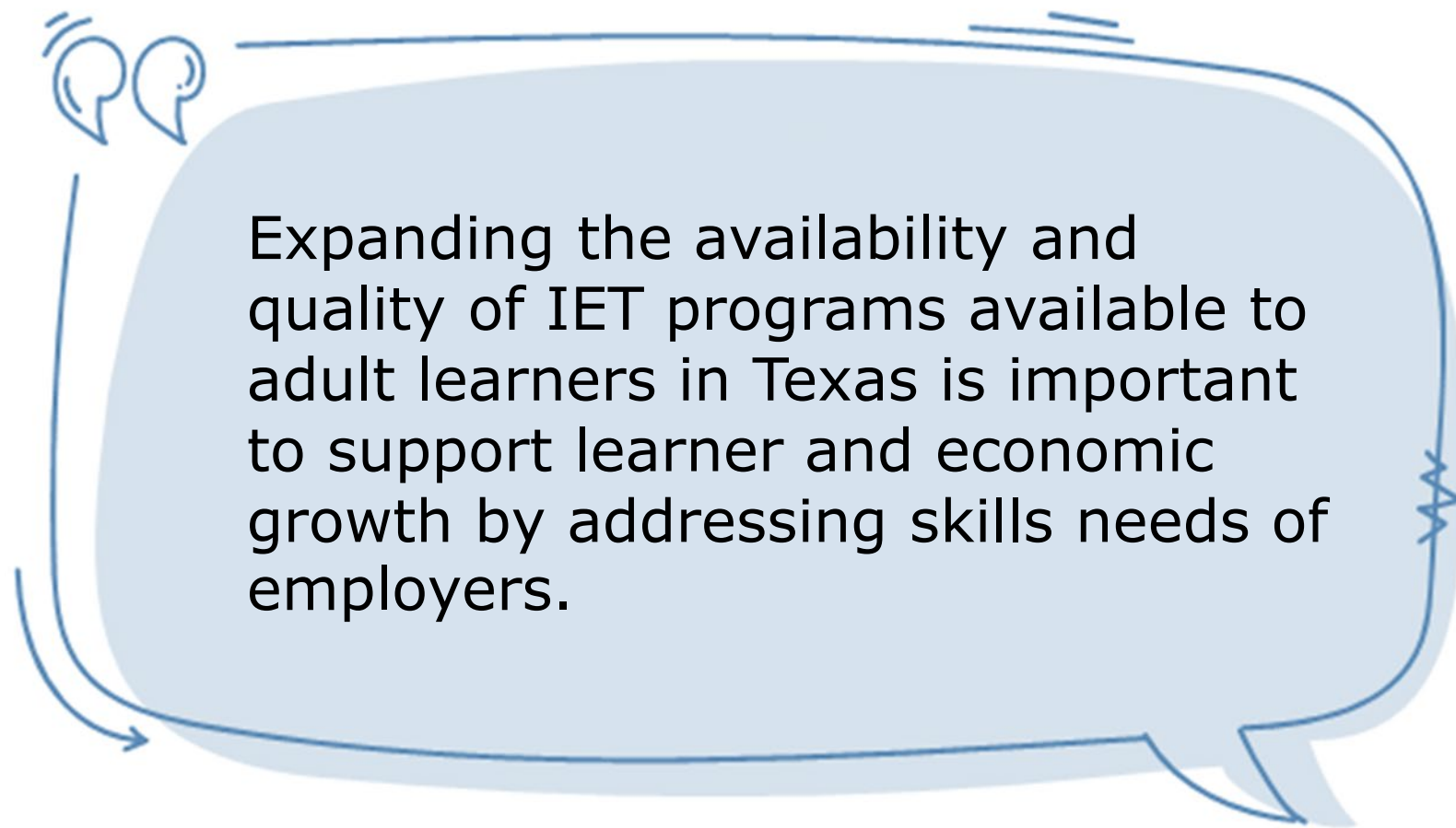
“The term “career pathway” means a combination of rigorous and high-quality education, training, and other services that—

- (A) align with the skill needs of industries in the economy;
- (B) prepare an individual to be successful in any of a full range of secondary or postsecondary education options, including apprenticeships
- (C) include counseling to support an individual in achieving the individual’s education and career goals;
- (D) include, as appropriate, education offered concurrently with and in the same context as workforce preparation activities and training for a specific occupation or occupational cluster;
- (E) organize education, training, and other services to meet the particular needs of an individual in a manner that accelerates educational and career advancement;
- (F) enable an individual to attain a secondary school diploma or its recognized equivalent, and at least 1 recognized postsecondary credential; and
- (G) help an individual enter or advance within a specific occupation or occupational cluster.”

IET is an integrated service approach that provides adult education and literacy activities concurrently and contextually with workforce preparation activities and workforce training for a specific occupation or occupational cluster for the purpose of educational and career advancement (§463.35) resulting in a recognized postsecondary credential and employment or further education and training (s).

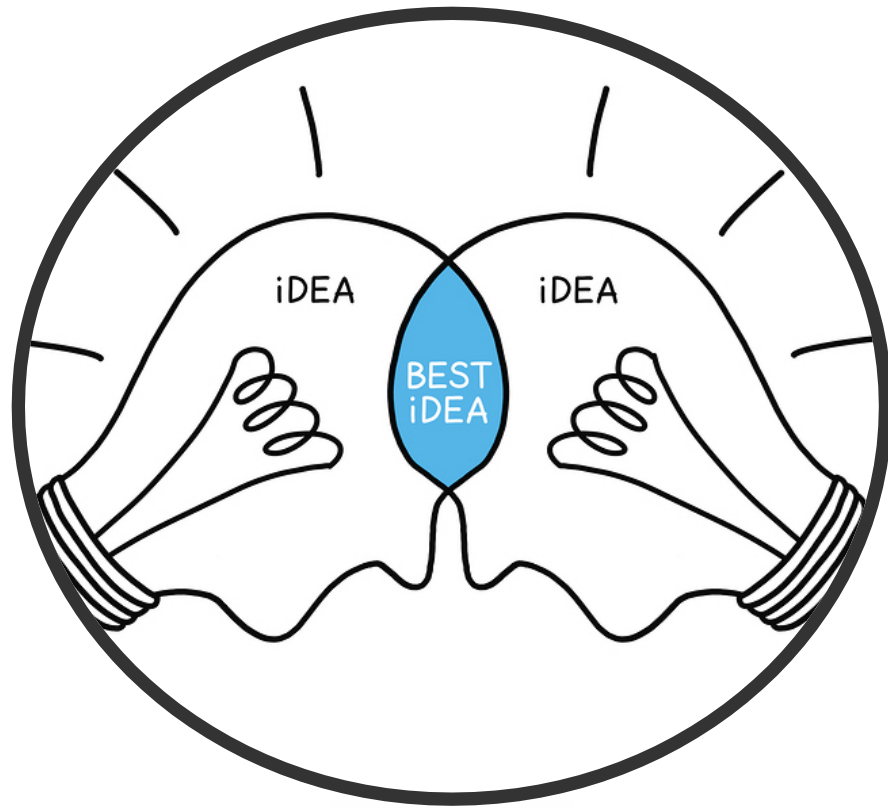

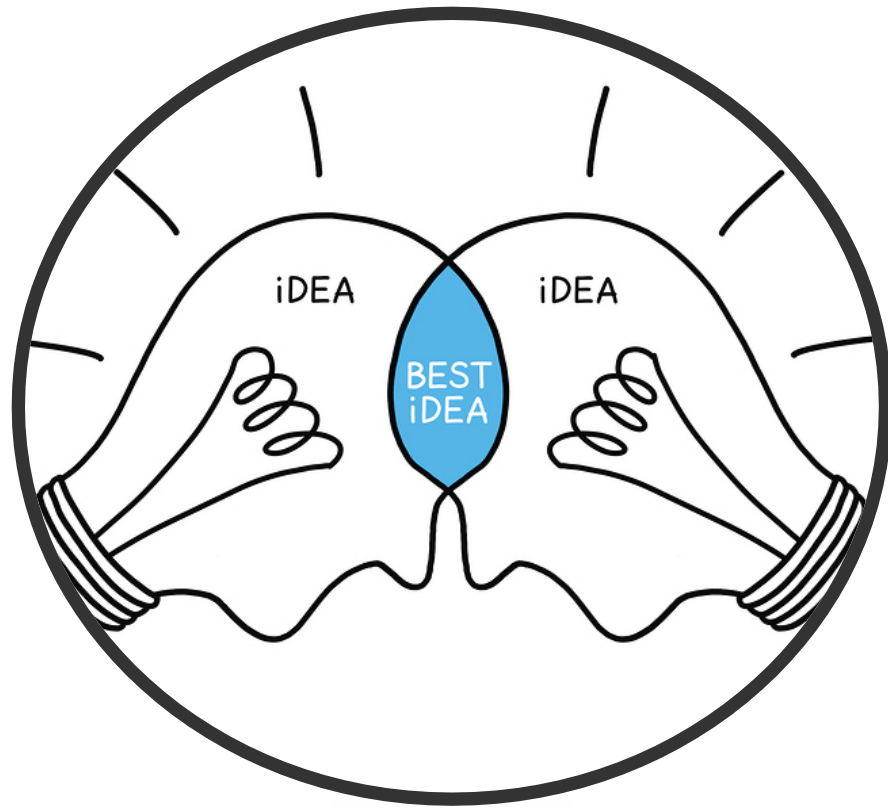

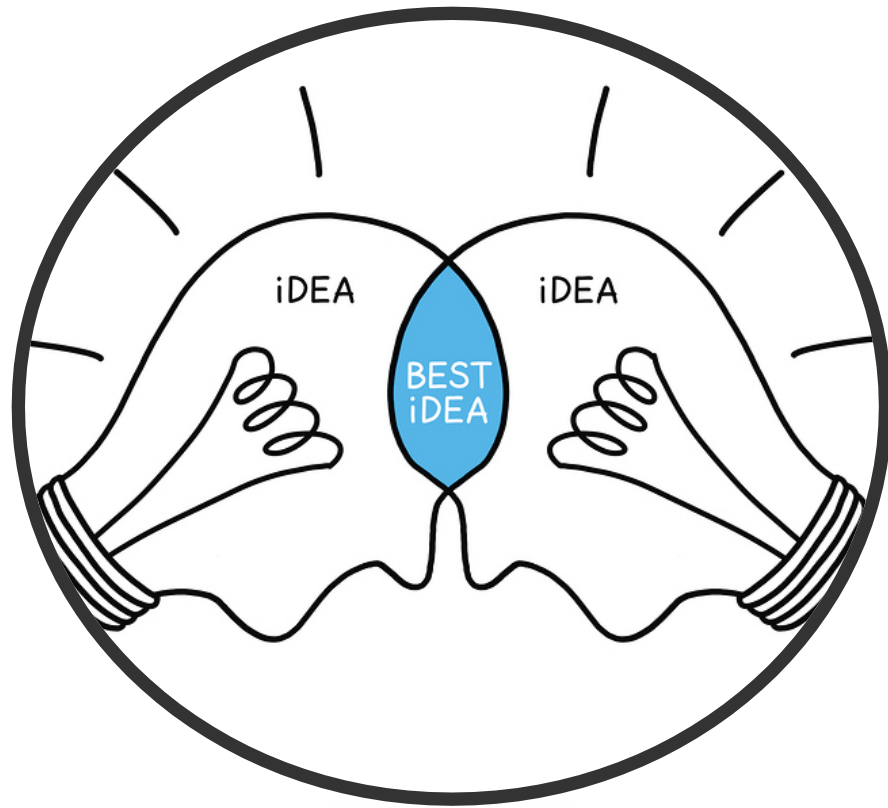


Adult Education and Literacy Activities. (AEL Activities) in IET means programs and activities in the content domains of reading, writing, English as a Second Language, and mathematics.

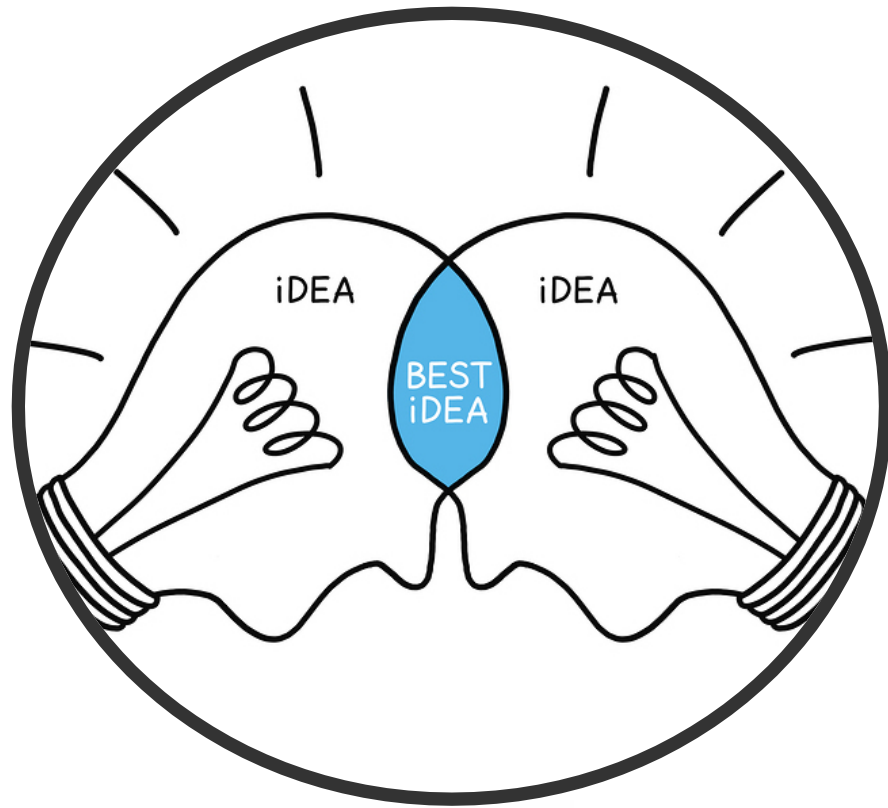

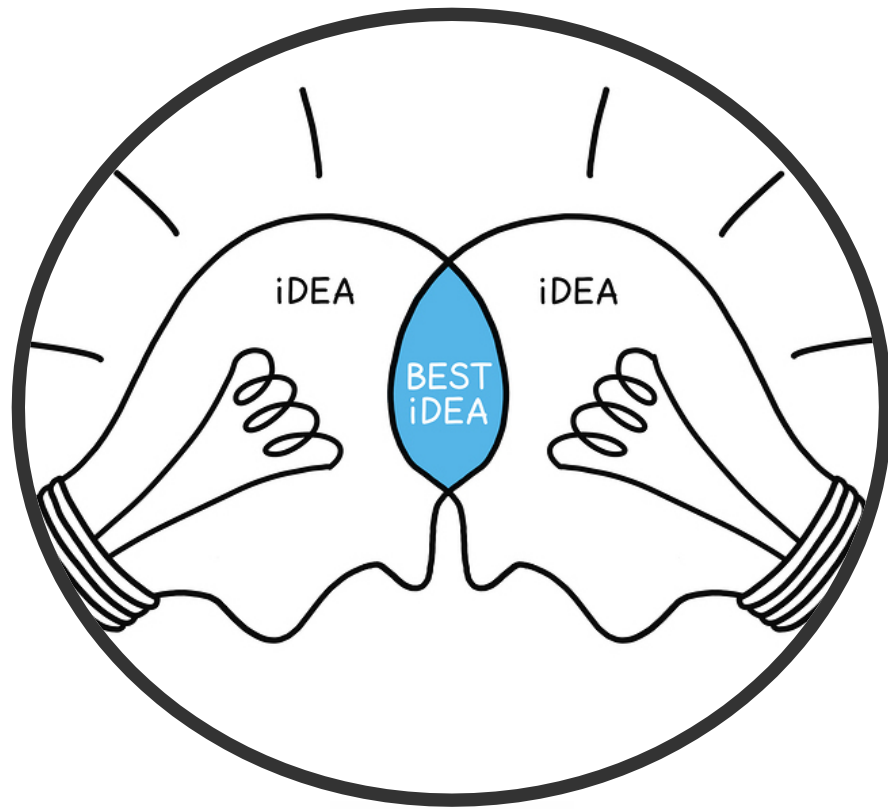
One (1) of the three (3) core IET Components, encompassing activities, programs, or services designed to help an individual acquire a combination of basic academic skills, critical thinking skills, Digital Literacy skills, and self-management skills, including competencies in the following:

- Using resources;
- Using information;
- Working with others;
- Understanding systems;
- Skills necessary for successful transition into and completion of postsecondary education, training, or employment; and
- Other employability skills that increase an individual's preparation for the workforce.

One (1) of the three (3) core IET Components, including the following training services authorized under WIOA Title I:

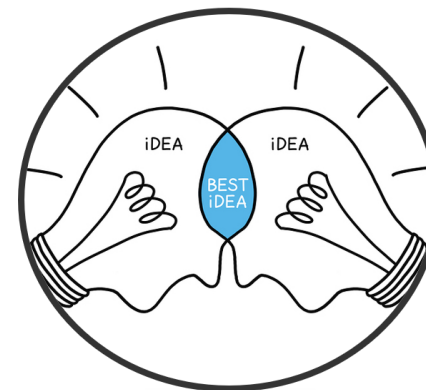
- On-the-Job Training as described in WIOA § 3(44);
- Skills upgrading (for example, training delivered in an IET by an employer);
- Entrepreneurial Training;
- Customized training, as described in WIOA § 3(14);
- **Other occupational skills training** (for example, training delivered in an IET by a community or technical college);
- Prerequisite training;
- Registered Apprenticeship training; and
- Youth occupational skills training.

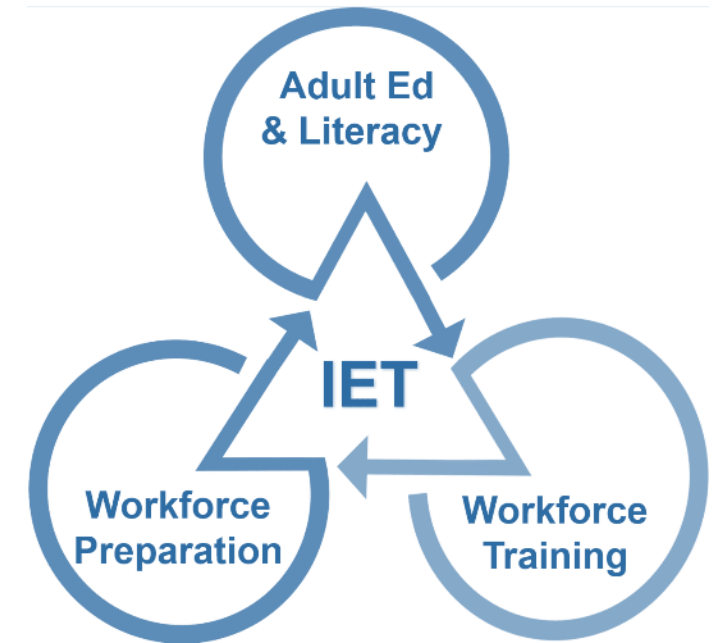

Key Takeaways:

Adult education and literacy activities, workforce preparation activities, and workforce training activities must:

- Each be of sufficient **intensity and quality**
- Be based on the most **rigorous research available**, particularly with respect to improving reading, writing, mathematics, and English proficiency of eligible individuals
- **Occur simultaneously** within the overall scope of the IET program
- Use **occupationally relevant** instructional materials



This alignment integration is organized through a **single set of learning objectives** that identifies specific adult education content standards, workforce preparation skills, and workforce training competencies.

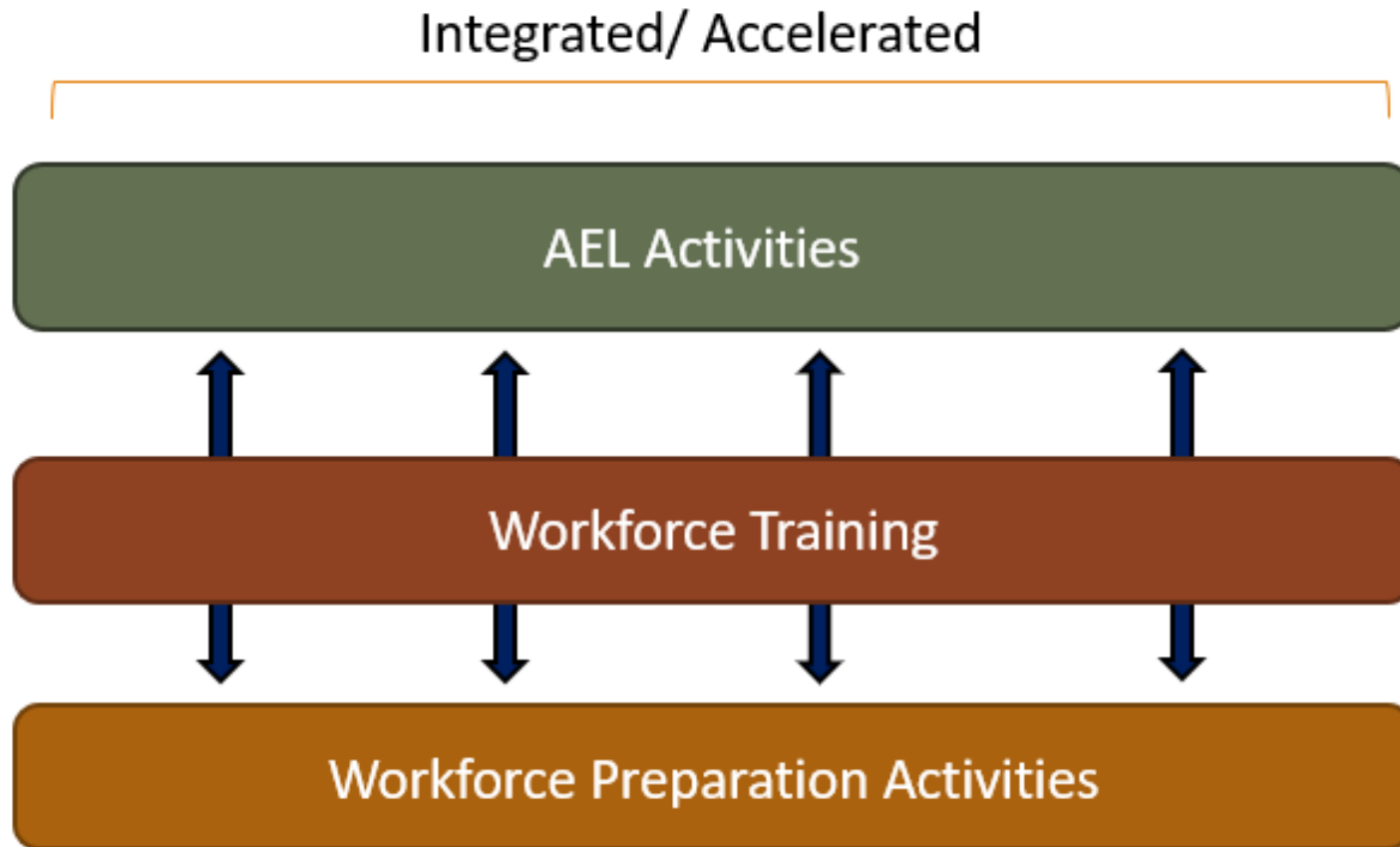

Educational and Career Advancement

The purpose of IET programs is to support learners' educational and career advancement.

To help achieve that:

- The adult education component of the program **must be** aligned with the state's content standards for adult education.
- The IET program **must be** part of a career pathway.
- In Texas the IET must lead to a Recognized Postsecondary credential

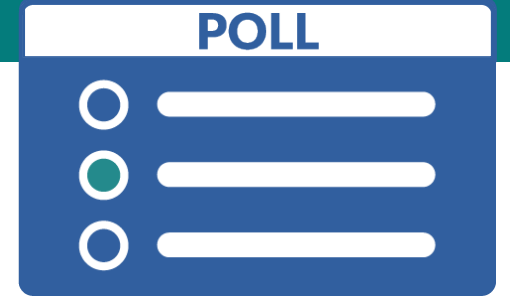

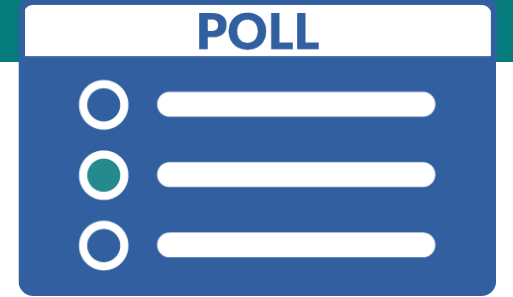

5. Determine whether the evidence is strong (S), weak (W), inferred (I), or non-existent (N), and enter the corresponding letter in the last column.
6. Once your group has gone through all the items in the left column, discuss whether you think you have enough evidence to determine whether the program qualifies as an IET program according to the WIOA requirements.

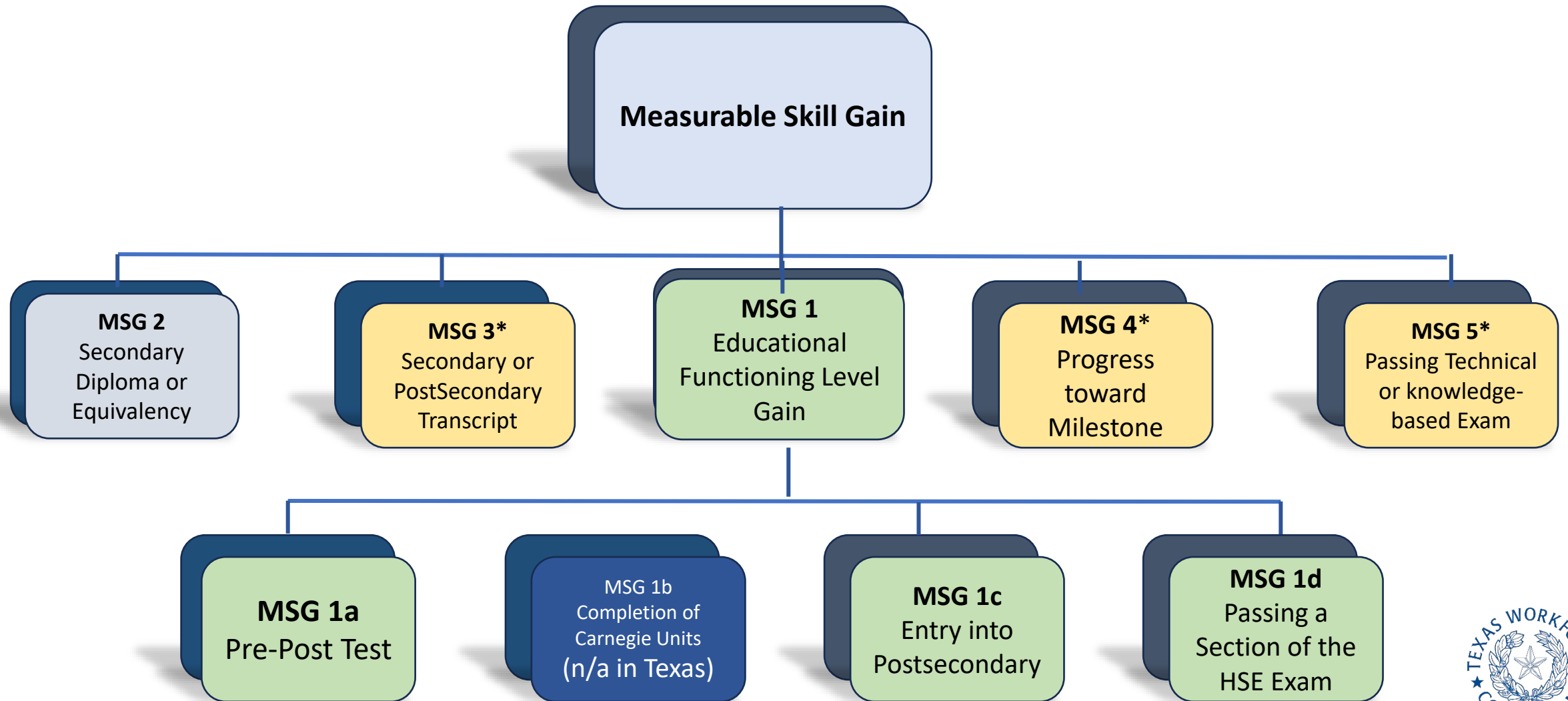

- ✓ AEL eligible
- ✓ An appropriate “fit” (seeking employment and/or further education along the career path)
- ✓ Available throughout the timeline
- ✓ Knowledge of the career path
- ✓ Aware of barriers and how to mitigate disruptions
- ✓ Self- assessment of readiness



Best Practice

Partners

Partners:

- ✓ Seek training providers (partners) willing to be flexible with design considerations
- ✓ Seek employers needing workers and willing to interview or do mock interviews
- ✓ Visiting presenters, job site tours, or provide internships
- ✓ Participate in identifying skills needed for entry level and mid skill level placement
- ✓ Review core competencies if not vetted by an employer or industry committee

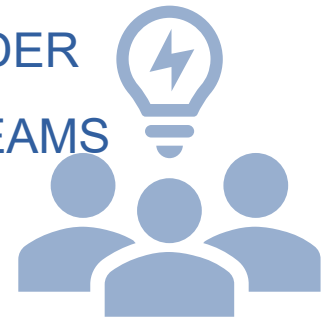

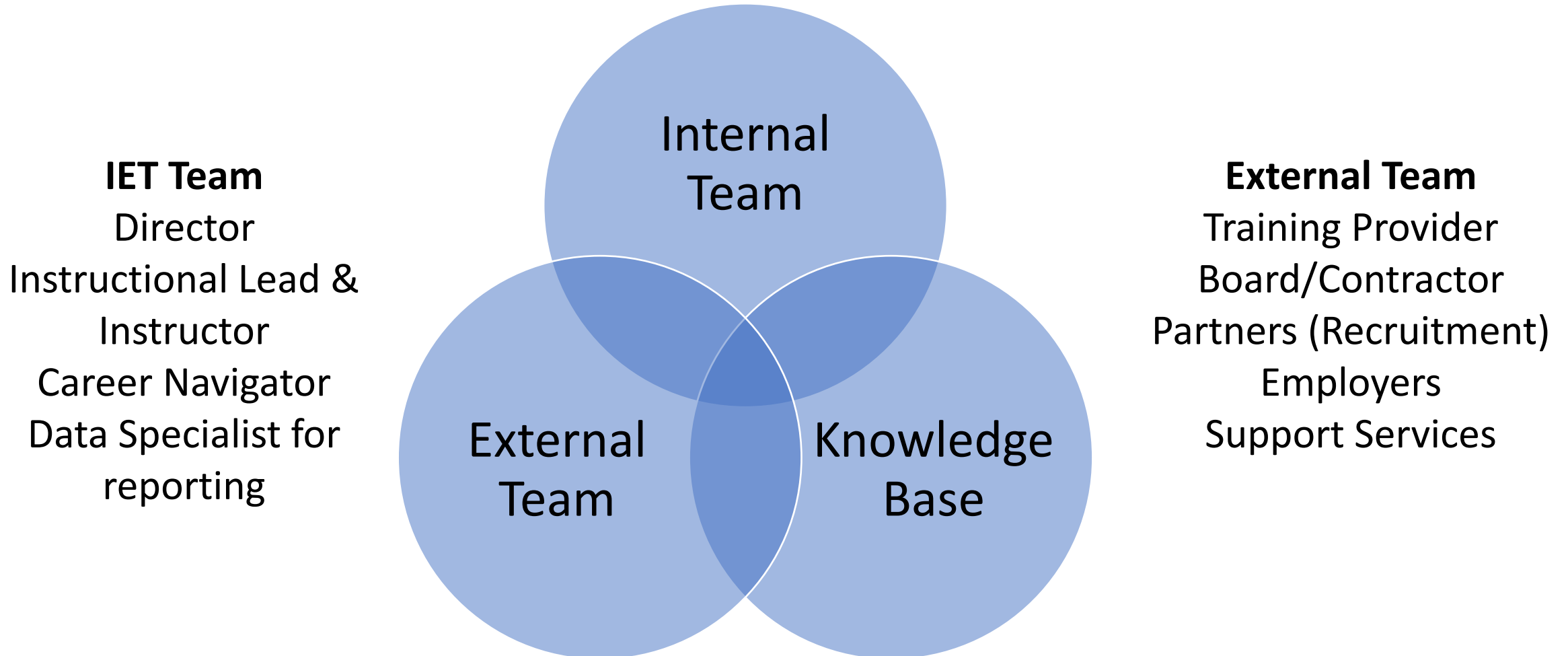

First a review

Funding Source vs. Cost Category

Funding Source means the lines of funding and where they came from.


Funding Sources:

- AEFLA 231 Funds
- AEFLA 243 Funds

Cost Category means the cost lines for CDER expenditure reporting.

Examples:

- Admin
- Career Services
- Program
- Training



AEL grantees must report Workforce Training expenditures as part of the monthly expenditure reports submitted through TWC's Cash Draw and Expenditure Reporting (CDER) system.

IET: Allowable costs

AEL funds may be used to pay for costs related to Workforce Training related expenses such as:

- Tuition for occupational training courses;
- Uniforms or other required training attire and training related tools, including work-related protective eye and ear gear;
- Books, fees, school supplies, and other necessary items for students enrolled in Workforce Training and
- Employment and training related applications, tests, and certifications.

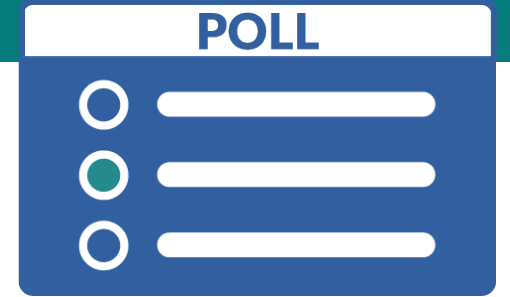
